### Methods and materials for containment and clean up

**Minor Spills** Ventilate area, avoid breathing of vapours.

Use absorbent clean up materials, such as fire retardant treated sawdust or diatomaceous earth.

Wear protective clothing and breathing apparatus.

Sweep up.
