

Product Warranty Statement

Warranty

1. Subject to the terms of this warranty statement, Kingspan Insulation NZ Ltd ("Kingspan") warrants to the original purchaser of a Kingspan product ("the Product") that the Product will, subject to compliance with the conditions below, be free from defects due to defective factory workmanship or materials. For the avoidance of doubt, the Product will not be defective for the purposes of this warranty to the extent that the Product is performing or operating within any applicable tolerance or rating (or similar) levels as set out in Kingspan's relevant published literature current at the time of purchase. Kingspan warrants to the original purchaser of any accessories in respect of the Product supplied by Kingspan that such accessories will be free from defects due to defective factory workmanship or materials.
2. Nothing in this warranty shall exclude or modify any legal rights or remedies a customer may have (to the extent applicable) under the Consumer Guarantees Act 1993 ("Consumer Guarantees Act"), the Fair Trading Act 1986, the Building Act 2004, Subpart 3 of Part 2 of the Contract and Commercial Law Act 2017 ("CCLA") in relation to misrepresentation, or any other enactment (except where and to the extent the enactment expressly permits the exclusion or modification of rights or remedies under it). For the avoidance of doubt, the Consumer Guarantees Act does not apply to any purchaser of the Product who acquires the Product for:
 - (a) resupplying the Product in trade;
 - (b) consuming the Product in the course of a process of production or manufacture; or
 - (c) repairing or treating in trade other goods or fixtures on land, and does not apply if the Product is not of a kind ordinarily acquired for personal, domestic or household use or consumption.
3. From the date of purchase, the term of the warranty in respect of the Product is:
 - (a) 10 years for Kingspan Insulation, STEICO and Troldekt products.
 - (b) 15 years for Kingspan Thermakraft flexible membranes, steel mesh, tape and accessories products.
 - (c) 1 year for FibroTech Quanti Acoustic Panels and accessories. 5 years for FibroTech Premium Panels.

Kingspan is not liable for any claim that is not lodged by the original purchaser within the term of the warranty.

4. The entity giving this warranty is Kingspan Insulation NZ Ltd (company number 6220850), a duly incorporated company having its registered address at 11 Turin Place, Ōtara, Auckland 2013. Its contact details are as follows:

Conditions of Warranty

This warranty is strictly subject to the following conditions:

5. Kingspan will not be liable for breach of warranty unless the claimant has a valid claim and submits a claim in writing to Kingspan. The written claim must be made within 30 days after the defect would have become reasonably apparent or, if the defect was reasonably apparent prior to installation, then the claim must be made prior to installation.
 6. The claim to Kingspan must include the following:
 - (a) proof of purchase;
 - (b) the name, physical address, phone number and email address of the original purchaser (as the claimant);
 - (c) the name and address of the licensed building practitioner (as defined in section 7 of the Building Act 2004) ("Licensed Building Practitioner") who completed the installation; and
 - (d) the date on which the defect became apparent.

For the avoidance of doubt, Kingspan will not process any claim under this warranty unless the claim includes all of the relevant documents and/or information set out in this clause 6.
 7. The warranty is personal to the original purchaser of the Product and is not transferable.
 8. The Product must be unaltered, internally stored, handled and installed by or under the direct supervision of a Licensed Building Practitioner strictly in accordance with the relevant Kingspan literature in respect of the Product current at the time of installation. The Product must be installed in conjunction with the components or products specified in the relevant literature.
- A Building may be excluded from the Warranty requirement in Clause 8 requiring installation by a Licensed Building Practitioner if the following conditions are met:
- (a) The building does not include "restricted building works" at the time of construction or during its useful life. Definition of restricted building works can be found on <https://www.building.govt.nz/>
 - (b) The building is designed by a Chartered Professional Engineer and a PS1 is provided.
 - (c) Building work is carried out in accordance with the design and a PS3 is issued to validate the building work at the specific site address meets the performance standards of the Building Code.
 - (d) The installation of Kingspan Thermakraft Underlays is in accordance with Kingspan's relevant published literature current at time of purchase.

9. The Product must be installed in accordance with all applicable legal requirements.
10. All other third-party products, including coating and joining systems, applied to, or used in conjunction with the Product must first have been verified by a Licensed Building Practitioner and/or an accredited laboratory as being compatible with the Product, must be applied or installed by a Licensed Building Practitioner, and must be maintained strictly in accordance with the relevant manufacturer's instructions and good trade practice.
11. The project in which the Product is used must be designed and constructed in strict compliance with all relevant provisions of the current New Zealand building code (as defined in section 7 of the Building Act 2004) ("Building Code"), regulations and standards and in accordance with the terms specified in any building consent issued by the local or territorial authority in which the project is being undertaken. If requested by Kingspan, the claimant must provide a copy of the building consent.
12. The claimant agrees to provide information in relation to the installation and/or maintenance of the Product reasonably requested by Kingspan in assessing any claim. Kingspan is not liable under this warranty if the requirements set out in clauses 8 to 11 have not been satisfied.
13. Notwithstanding any other provision contained in this warranty, the claimant's sole remedy for breach of this warranty is that Kingspan will, at its sole discretion, elect to:
 - (a) supply a replacement for the defective Product;
 - (b) rectify the defective Product; or
 - (c) pay the cost of the replacement or rectification of the defective Product.

If a defective Product is repaired or rectified, the original warranty period will continue to apply based on the original date of purchase of the relevant Product.

Subject to clause 2 and to the maximum extent permitted by law, Kingspan's liability for failing to comply with any statutory guarantee (or liability under any other warranty, condition or indemnity that cannot be excluded) is limited in the same manner as set out in this clause 13.
14. The claimant is responsible for its expenses in making any claim against Kingspan under this warranty.
15. If Kingspan determines that a claim is not valid, Kingspan may charge the claimant for any labour, materials or transport costs incurred by it in assessing the claim.
16. Subject to clause 2 and to the maximum extent permitted by law, except as expressly set out in this warranty, Kingspan will not be liable for any losses or damages (whether direct or indirect) including property damage or personal injury, consequential loss, economic loss or loss of profits, arising in contract or negligence or howsoever arising. Without limiting the foregoing, Kingspan will not be liable for any claims, damages or defects arising from or in any way attributable to poor workmanship, poor design or detailing, settlement or structural movement and/or movement of or failure of materials to which the Product is attached, incorrect design of the structure, acts of God including but not limited to earthquakes, cyclones, floods or other severe weather conditions or unusual climatic conditions, normal wear and tear, damage caused by contact with aggressive chemicals, fire and smoke, incompatible metals, immersion in water, growth of mould, mildew, fungi, bacteria or any organism on any Product surface or Product.
17. Subject to clause 2 and to the maximum extent permitted by law, all warranties, conditions (including those under Part 3 (Sale of Goods) of the Contract and Commercial Law Act 2017), liabilities and obligations other than those specified in this warranty are excluded.
18. Any references to statutes or statutory provisions in this warranty include those statutes or statutory provisions as amended, extended, consolidated, re-enacted or replaced from time to time and any orders, regulations, instruments or other subordinated legislation made under them.
