Terms and conditions

- 1. This warranty does not cover:
 - a) Any act of God (including earthquakes, fires, cyclones, floods or other severe weather conditions, or unusual climatic conditions), any natural occurrence or any other circumstance beyond PSP Limited's control; or
 - b) Application design or installation in any respect, or the failure to follow any procedures or guidance (if any) that may be issued in the ClearVue Roofing System Technical Information made available by PSP Limited, or not adhering to best building practices in accordance to the New Zealand Building Code when installing the ClearVue Roofing System (including, but not limited to, incorrect flashings, fixings or the use of incorrect adhesives, or incorrect application of adhesives); or
 - c) Failure to follow the maintenance and the cleaning guide for ClearVue Roofing System Technical Information made available by PSP Limited; or
 - d) Physical abuse, misuse, accidents, impacts, incorrect handling, wear and tear; or
 - e) Failure of any adhesive, caulk, sealant or other accessory, or failure of any caulked or filled joint or seams; or
 - f) Events directly or indirectly attributable to the underlying substrate or structure, including building framing, building substructure or anchoring systems, or failure to any substrate or structure caused by design flaws, overloading of structure, building movement, or any consequential or indirect loss or damage caused or contributed to by any defect; or
 - g) The product being used in applications not expressly recommended in the ClearVue Roofing System Technical Information made available by PSP Limited; or
 - h) Any part of the ClearVue Roofing System that is not installed by a skilled person whom is competent to install the ClearVue Roofing System; or
 - i) Variation in colour of the material against the sample material, displays and/or printed illustrations; or
 - j) Costs, losses or any other damages relating to:
 - (1) the removal of the defective products or systems; or
 - (2) the installation of replacement products or systems; or
 - (3) restoration work; or
 - (4) any other direct, indirect or consequential costs, losses, expenses or loss of earnings;

The ClearVue Roofing System is deemed non trafficable. Under no circumstances should the ClearVue Roofing System be walked on or used as a building scaffold apparatus.

2. Subject to the terms and conditions of this warranty, this warranty applies only to the ClearVue Roofing System:

- a) Which has not been removed from its original place of installation;
- b) Which has been installed by a skilled person whom is competent to install the ClearVue Roofing System;
- c) Which has been installed, maintained, and cleaned in the manner set out in ClearVue Roofing System Technical Information made available by PSP Limited; and
- d) Where PSP Limited has been notified of the defect within seven days of the customer discovering the defect, or within seven days of such time as the defect ought reasonably to have been discovered (whichever is earlier).
- 3. Other than as provided in these terms and conditions, PSP Limited will have no liability to a claimant (whether in statute, contract, tort (including negligence), or otherwise at law or in equity) in respect of any defects in the system or for any loss, damage, costs or expenses caused by the product or defects in the system.
- 4. PSP's liability in respect of all claims under this warranty shall not exceed the price of the ClearVue Roofing System concerned.
- 5. Nothing in this document shall exclude or modify any legal rights a customer may have under the Consumer Guarantees Act or which otherwise cannot be excluded or modified at law.
